# **Children at Residential Events**

# Thomas Hall Trust regulations

"Thomas Oswald Hall bequest (from original will): "As to five equal twentieth parts or shares UPON TRUST to pay the income to arise therefrom to MARY COCK the daughter of my late brother-in-law LESLIE NORMAN ROBEUCK during her lifetime AND from and after the death of the said MARY COCK to stand possessed of such share both as to capital and future income UPON TRUST for THE PRESBYTERIAN CHURCH OF VICTORIA SOCIAL SERVICES DEPARTMENT for use in connection with the care of children in Cottage Houses and ST JOHN'S HOME FOR BOYS AND GIRLS Canterbury in the said State in equal shares." Minute 286/08 of the meeting of the Trusts Corporation on 19 August 2008 records that it was agreed to allocate the funds from the T O Hall Bequest to Social Services for purposes as near as possible to those contained in the will, for use in connection with the care of children, preferably in some form of residential care, under the auspices of or associated with the Presbyterian Church of Victoria; and that if no such opportunity exists the Trusts Corporation is entitled to wait for a reasonable time before deciding what use they may make of the gift."

2.4 A child (under 18) from a Presbyterian congregation attending the minister's family camp

2.5 Someone from a Presbyterian congregation attending an Engage conference to be trained in Youth or Children's ministry.

#### 3.0 Availability of Funds

3.1 In the event of multiple residential events in a single year the Committee will seek to distribute funds equitably across the state so that the children of each congregation have the possibility of benefiting particularly favouring congregations with fewer financial resources.
