#### **OUR GOD WAS WORSHIPPED...**

The 173<sup>rd</sup> General Assembly began with worship held in Scots' Church, Melbourne on the evening of Monday October 6 at a service in which **Rev Rod Waterhouse**, recently retired from Portland PC, was installed as Moderator. Rod preached a heartening and helpful sermon based on the Apostle Paul's visit to Thessalonica in Acts 17:1-10 and his subsequent letter to them in 1 Thessalonians 1:1-10 entitled, 'What am I doing here?', encouraging us all to be faithful witnesses for the Lord Jesus. A time of fellowship and supper followed the joyful occasion.

The Assembly remitted (i.e. sent to Presbyteries for approval/disapproval) proposed amendments to the Code (the rules of the Church).

- At 1.11.9 regarding the insert of relevant notes into the Code.
- At 4.156 and 5.49 regarding the examination of Presbytery and Assembly committee records.
- At 4.52 and 4.53 regarding leave of absence.
- At 3.40 regarding the election of deacons.
- At 4.55.1 regarding who may be authorized to hold a marriage licence within the PCV.
- At 2.48.1 regarding payment of current terms of settlement.
- At 2.13A, 2.14, 2.15, 2.45, 2.45A and 4.81 regarding approval of budgets by congregations.
- At 2.35A, 2.35.4, 3.6A, 3.40A, 3.40.9, 4.47A regarding holding a WWCC.
- At 6.10.7 regarding sitting in private.

### **SESSIONS WERE ENCOURAGED...**

- To encourage women to make use of the resources in the WMV website, engage with WMV social media channels and direct 'key' women to attend the Leadership Training Day on 18/10/25.
- To identify women who could benefit from a gospel coaching relationship with the WMV coach.
- To prayerfully consider opportunities for ministry presented through the HCC committee.
- To consider the mother-daughter model of church planting in consultation with the CPC.
- To ensure that existing elders and deacons undergo the Safe Church Volunteer Approval Process.
- To identify and disciple suitable young people to be the next generation of leaders in the PCV
- To make use of the PYCC Discussion Paper for Children's and Youth ministry.

### **KEY DECISIONS WERE RESOLVED...**

The bulk of the General Assembly's time is taken up with the committee reports and from these many decisions were made by the Assembly, including:

- Adopting the Affirmation Model paper (relating to gender ideology) prepared by the Church and Nation committee and resolving to distribute it to Victorian parliamentarians.
- Agreeing to the dissolution of the Mt Prospect, Hume and Stanhope congregations, as requested by their Presbyteries, permitting the sale of the properties associated for the purposes stated.
- Amending Church and Nation Committee regulations so that the committee will now be referred to as the 'Gospel, Church and Nation Committee'.
- Amending various Long Service Leave regulations and the payment of LSL levy.
- Amending the membership of the Exit (Students) Committee.
- Appointing Rev Ian Hutton as the Convener of the Business Committee.
- Approving the insertion of various notes in the Code for explanation and information.
- Approving the position descriptions for the Ministry Development Officer, Coach & Administrator.
- Authorising the Clerk (representing the PCV) and Rev Phil Campbell (representing Scots' Church) to finalise all matters in relation to the 'GAV having a minority interest in the Assembly Hall'.
- Authorising the Clifton Hill and Hawthorn congregations to access further Sites Reserve funds.
- Authorising the Presbytery of Geelong to halt the sale of the St George's Church, Geelong.
- Commending the National Journal Committee (GAA) for the recent printed edition of the 'Australian Presbyterian', recommending that further publications would be welcome.
- Consenting to the transfer of all property for the purposes of the Auburn (Chalmers) congregation from the local trustees to the PCV Trusts Corporation.
- Consenting to the transfer of all property for the purposes of the Hawthorn congregation from the local trustees to the PCV Trusts Corporation subject to the congregation providing confirmation.
- Enacting new rules in the PCV Code; 2.20(e), 3.38, 4.18.4, 4.31.2(b), 4.68A.2, 4.68B.2, relating to the Safe Church Volunteer Approval process, purchasing an existing building, approval of budgets, counting of votes in a Board election, urgent meetings of Presbytery and the basis of the union of congregations.
- Encouraging the Church Planting Committee to consult with the MDC and the CGAC to propose necessary changes to allow financial support for mother-daughter church plant projects.
- Permitting the Safe Church Committee to further report to the GAV Commission in May 2026.
- Receiving the reports of the Board of Investment & Finance and the Trusts Corporation.
- Remitting various items of business to the Commission of Assembly in May 2026.
- Revising the Long Service Leave levy for 25/26 to \$1,300.
- Sending greetings to His Majesty, King Charles III, and the Victorian Premier, Hon. Jacinta Allan, assuring them of the Assembly's prayers.
- Thanked and discharged the ad hoc committee on Deacons.

#### FINAL PRAYERS WERE OFFERED...

The Assembly concluded its business with prayer and a hymn and the benediction on Thursday afternoon (not as long as last year's that went until the Friday afternoon). All in all, the Assembly was marked by good debate with a harmonious tone, finally resolving to meet as a Commission on May 5, 2026 and then again in General Assembly on October 5, 2026.
